# **Terms of Reference**

# "Climate change and natural disaster vulnerability study of women and children in coastal Odisha"

#### **BACKGROUND**

Odisha has witnessed one of India's first cases of climate displacement after decades of slow shoreline changes and coastal erosion that sparked involuntary displacement and migration around several villages in the Kendrapara district. These areas mostly lie around the village of Satabhaya (locally understood as seven villages) with agriculture and fishing as the mainstay of the community. The Government of Odisha has relocated 571 families from the eroded village of Satabhaya to the hamlet village of Bagapatia in Gupti GP of Rajnagar in June 2017. The families are described by some as India's first "Climate Refugees".

With the support of Misereor, Germany RCDC has, in the month of December 2021, launched a program titled, "Ensuring rehabilitation, skill building, livelihoods and resilience of climate displaced people of Bagapatia in Kendrapada district of Odisha" in the Bagapatia resettlement colony of relocated Satabhaya Gram Panchayat in Rajnagar block of Kendrapada district in Odisha, India.

#### The Project objectives are:

- Improving the living conditions of 719 displaced and to be displaced families of Satabhaya to Bagapatia resettlement colony
- Facilitating Skill building and providing material support for promoting alternative livelihoods for the communities

# Purpose of the Study:

The study is titled; "Climate change and natural disaster vulnerability study of women and children in coastal Odisha" will be conducted in the Bagapatia resettlement colony situated in the newly constituted Satabhaya Panchayat in Rajnagar Block of Kendrapara district in Odisha. In the said sturdy, the following aspects will be covered.

- Socio-economic and demographic profile of the selected HHs.
- > Principal means of livelihoods of the household
- Climate change issues and impact of climate change
- History of major disaster since 1999
- What are the major changes found in the area, Reasons and impact
- Vulnerability assessment for flood and waterlogging (Physical & structural vulnerability, economic vulnerability, social vulnerability, psychological vulnerability, environmental vulnerability)
- Impacts on fauna (including birds & aquatic life), Impact on public health, drinking water supply, communications and quality of life, Impact on the children
- Decision making processes and women role
